**Operations**

#### **Apparatus**

Engine 294 remains in service. Engine 94 is out of service. There is nothing wrong with the engine, the new grass rig has been placed in service.

Caliveras Consolidated will be donating a low mileage engine to the department. The apparatus is in mint condition. The only cost would be for the labor on completing the air conditioning, which is estimated to be about \$5,000. Engine 94 could be sold once the new engine arrives.

#### Grants

SCBA has reached out with further clarification on the \$170,000 grant application. Chief is hopeful that a decision will be communicated within a couple of weeks.

No word from AFG on the grant application.

Matthew Hawkins has reached out and indicated that the beneficiary questionnaire would not be sufficient to release the grant funds. Suzanne will reach out to Rebecca Sloan to set up a meeting with Pat Hume to see if he can be of assistance.

CalFire Volunteer Fire Capacity Grant of \$12,000 has been awarded! It will be used for hoses and hose testing.
