### Residential Yard Clippings/Organic Waste Only

#### REQUIREMENTS FOR BURN AREA

1. Must minimally have a **25-foot** firebreak clearance around burn pile to prevent fire spread, including overhanging tree branches. Clearance area includes baredirt.
2. Trimmings shall be no larger than **5-inches** in diameter, pile height shall be no greater than **5-feet** and pile width at the base shall be no greater than **5 X 5** feet.
3. Control burn must be attended by at least one adult at all times.
4. Provide approved on-site fire extinguishing equipment, such as 4A fire extinguisher, garden hose, water truck, water barrel, etc.
5. Burning is the responsibility of the permittee. Violations and fire spread may result in citations and suppression fines.
6. You may only burn residential yard clippings such as grass clippings, tree/shrub clippings, leaf matter, etc. Refer to Rule 407 outlined in the SMAQMD Regulations.
7. Burning household refuse, rubbish, garbage, trash, painted lumber/construction material, tires, etc. is illegal. Other means of disposal must be used for these materials.

#### **NO BURNING ALLOWED BEFORE 10 A.M. or AFTER 5 P.M.**

All fires must be extinguished by 5 P.M.

I am the legal representative/owner/of the above described property. I agree to comply with all applicable fire laws, ordinances, and regulations. I further agree to relieve River Delta Fire District of all liability for control burn and will comply with the specific terms of this permit. My permit may be revoked, suspended and or suppression fines may apply for violations of permit conditions.
